Annex1 / Notes&Hints:

- Fees must be paid even in cases of illness, vacation, non-participation in training or matches, or cancellations by authorities. Refunds are excluded. Membership fee is always annual^{2 3 5}, regardless of chosen payment interval.
- Membership does not end automatically when a minor turns 18.
- Entry into the club before December 1st requires payment of the full annual fee!
- According to the 2017 amendment to the department regulations approved by the general
 meeting, in addition to the annual club dues for active members in the EHV/DEB game operations,
 the corresponding amount of the dues for uncompleted "work service3" will be collected at the
 end of the season. The hours are recorded using work cards, which are signed by the team
 managers.
- Normal withdrawal or termination from the club is possible at the end of each fiscal year, on April 30th. The termination must be received in writing (by mail or email) by December 31st of the current year at the latest to the board of the Iserlohner EC Nachwuchs e.V.-Young Roosters. A revocation can/must also be received in writing at the Iserlohner EC Nachwuchs e.V.-Young Roosters office by March 31st otherwise, a new club registration, which is subject to a fee, is required! (Fiscal year: May 1st April 30th).
- If a player is excluded for sporting reasons by the coach, no notice period (at the end of the season) is to be observed ⁶
- A separate contribution / discount for dual license applicants is excluded
- The ice skating school's special right of termination is available at the end of the current month, effective on the 15th of each month. Notice of termination must be received in writing (by mail or email) by the board of the Iserlohner EC Nachwuchs e.V.-Young Roosters.
- The Kids Club discount is only valid in the first year / until the ice skating badge is achieved

The personal data provided, in particular name, address, telephone number, bank details, etc., are necessary and mandatory solely for the purpose of implementing the resulting contractual relationship. A separate declaration of consent will be obtained for the publication of images and data on the website (see page 2).
