



Privacy policy of the Iserlohner EC Nachwuchs e.V. – Young Roosters

Preliminary notes

Iserlohner EC Nachwuchs e.V. (hereinafter referred as "we," "us," "our," or "Young Roosters") is responsible for the data protection of its members. For better readability, gendered language is not used; all personal terms apply equally to all genders.

If personal data is collected from the data subject (e.g., on an application for membership), we must provide the data subject (e.g., the potential member) with the necessary information at the time this data is collected, for example, at the same time as the application for membership. The information may be provided in writing or in another form, possibly also electronically, e.g., by email and/or on the website, provided that all requirements (in particular, easy accessibility at the time of data collection) are met. We may therefore provide this information to our members, for example, on the application form, via flyers, by email, and/or on the website.

It is important to us that your personal data is protected

II. Purposes of Data Processing

We process personal data of our members, officials, event participants, and visitors to our services for the following purposes:

1. Membership management and club organization

- Management of member data (e.g., name, address, date of birth, contact details, bank details for membership fees)
- Conducting club operations (e.g., organizing training, events, meetings, appointments, news)

2. Contribution collection and financial management

- Management of membership fees
- Processing of donation receipts



3. Transmission to umbrella associations, specialist associations, and statistical databases

- Data transfer to higher-level associations (e.g., state sports associations, professional associations such as the Ice Sports Association EHV or the German Ice Hockey Association – DEB) for the conduct of game operations (fulfillment of licensing and game management requirements)
- Data transfer to statistical and organizational databases:
 - Hockeydata/Gamepitch (game and league management)
 - SpielerPlus (team and training organization)
 - RODI DB (player and club statistics)
 - Eliteprospects (public sports and performance statistics)

4. Data exchange with the main club

- Exchange for consistent administration and coordination

5. Public relations & image rights

- Photos and videos in print media, website, and social media (in descriptive match reports, press articles, reports), as well as for personal and team presentations of players, coaches, and officials
- By giving your consent, you grant us the right to use and publish your image for club purposes. The provisions of Sections 22 and 23 of the German Art Copyright Act (KUG) regarding image rights are maintained
- This assignment is valid until your consent is revoked. A **revocation takes** effect for **the future**; Previous publications (e.g., printed brochures) **cannot be removed**
- Individual images of spectators will not be published/transmitted. If the captions for photos or reports refer to specific individuals, only the first and last name, club, age group, and function within the club will be published/transmitted, if necessary

6. Insurance purposes

- For the purpose of concluding insurance contracts involving members, we may be required to disclose personal data of members covered by the insurance to the insurer.

7. Public authorities and security

- We may be required to disclose excerpts from your information (including inventory surveys for granting funding) to public authorities such as the North Rhine-Westphalia State Sports Association, the City of Iserlohn, the Iserlohn City Sports Association, the North Rhine-Westphalia Ice Hockey Association, and the German Ice Hockey Association.



III. Duration of storage

We only store personal data for as long as necessary to fulfill the club's purposes or due to legal retention obligations. However, for a maximum of two years, unless there are statutory, contractual, or statutory retention periods to the contrary.

IV. Who will receive the data

Your data may be shared with the following parties:

- Umbrella and professional associations (e.g., EHV, DEB)
- Statistical and organizational systems (e.g., Hockeydata/Gamepitch, SpielerPlus, RODI DB, Eliteprospects)
- Authorities, if necessary
- Our main club
- Service providers (e.g., insurance companies)

V. Transmission of member lists containing personal data

Member lists will only be released to board members, the main club, or other officials if their function or specific responsibilities within the club require them to know them. If a member credibly demonstrates that they need the member list to exercise their statutory rights (e.g., minority rights, participation rights), the necessary data will be provided to them in return for a written commitment that names, addresses, and other data will not be used for other purposes and that the data received will be deleted once their purpose has been fulfilled.

VI. Your rights

You have the right at any time:

- to know what data we have about you
- to have inaccurate data corrected
- to have data deleted
- to object to the use of your data
- to withdraw consent
- the right to lodge a complaint



VII. Consent

- We process your personal data on the legal basis of Art. 6 (1) GDPR. Unless the processing is already justified by statutory provisions, data processing requires the consent of the data subject (Art. 7 GDPR). If such a case occurs, we will provide the data subject with a declaration of consent. Consent is voluntary. **Both parents of underage** club members must give their consent; Minors who have reached the age of 14 also provide their own consent.
- **Revoking consent**
Under certain circumstances, if you have given us your consent to process and transfer your personal data for a specific purpose that is not covered by the statutory authorization, you have the right to revoke your consent for that specific purpose at any time. The revocation must be made in text form (Section 126b of the German Civil Code) to the address specified in (I.). Once we receive notification that you have revoked your consent, we will no longer process your data for the purpose(s) to which you originally consented, unless we have another legitimate and legal basis for doing so.

VIII. Right to lodge a complaint

As a member of Iserlohner EC-Nachwuchs e.V., you have the right to lodge a complaint if you believe that the processing of your personal data is unlawful. The address of the supervisory authority responsible for our association is:
